Food/Housing, personal and transportation expenses for summer: divide by nine and multiply by 2 months. Summer is based on 14 units. For LHT summer session it is 3 units x \$46 plus \$17 health fee plus \$1 student representation fee.

Books and supplies calculation for less than half time student: divide academic year (9 month) costs by 4 for two semester amount (then this figure by 2 for one semester & summer amount). Transportation expenses; divide full year cost by 4 for less than half time student cost for the year (there are no Food/Housing or Personal expenses for LHT). LHT fees for a semester are based on 3 units x \$46 per unit plus \$20 health fee plus \$2 student representation fee.
