# **Academic Senate President's Report**

## **April 17, 2023**

#### **District Executive Council (DEC)**

- Reviewed agenda for Board Meeting. Expressed concerns regarding Cuyamaca curriculum packet proposing Math 176 with removal of Math 110 pre-requisite. Campus procedures indicate unaligned courses cannot move to Board meeting. After several comments, Chancellor requested that both colleges have emergency meeting to conduct mediation. Met with College Presidents, VPAA's, Senate Presidents, Curriculum and Articulation Chairs, and Math Department Chairs. Discussed for an hour and a half and reached consensus. Item pulled from the Docket and Math department chairs will meet to discuss further. Excellent example of collaboration, community and studentcentered decision making.
- District has a deadline to submit an action plan regarding campus policing from an equity lens.
- The request for proposals were sent out for food vendors. The deadline to respond is 4/19/23. The task force will meet afterwards to evaluate the proposals.

#### Governing Board Meeting (3/14/23)

 Athletics presentation showing excellent success outcomes for athletes attending tutoring sessions. Cuyamaca Senate President expressed disapproval over removal of constituency representative tables and 4 minute oral report. Board passed resolution in support of keeping Area E for CALGETC. Board passed resolution ending vaccination requirement for employees effective June 1. Salary equity for Classified Professionals passed with several positions moving up in class level.

### **Additional Highlights**

Kerry Kilber and Barbara Gallego will be meeting with GC and CC Senate Presidents once a month to discuss any items that may touch on 10+1. Met for first time on April 5. Discussed transitions in staffing in IT, Perkins Survey on Canvas and Self-Service updates. There is a plan to move the Perkins survey to Self-Service, but it is difficult to program. Barbara asked for one more semester of placing survey in Canvas prior to moving it

- permanently to Self-Service. Will continue to be optional and not required. Will also ask about rewriting some of the questions, which are personal in nature.
- District IEPI team met for first time on April 5 to look at summary of comments and list of themes identified. Writing team will meet on April 14 to identify goals which will be submitted to request funding. Will bring final copy to Senate.
- Received final copy of ASCCC Resolutions. In attachments folder. Please review and provide feedback on pro or con statements and any preference on how to vote.
- Chancellor Neault had requested a meeting to discuss security cameras. Decision was made to postpone and bring the group together at a later date to discuss in more detail and hear out all concerns before moving forward.
