ANTHROPOLOGY

- Program Modification: Anthropology, AA-T
 - Suggested edits to paperwork for how it should read into the catalog

BIOLOGY

- Course Addition: BIO 100
 - Barrow: Why was a permanent COR provided since the course hasn't been run yet?
 - Aceves: To avoid gap year and offer it in the fall to have it in the catalog
 - Venard: Will this be a credit course or non-degree course? Most support classes tend to be non-credit.
 - Aceves: Will follow up to address credit issue. Might be due to confusion when form was submitted.
 - Ayala: Instructional Facilities is more complicated than a standard classroom. They
 are requesting a few things beyond what is included in standard classroom.
 Suggestion is that it gets classified differently.
 - Aceves: Suggestion can be made to list standard classroom and then biological lab equipment to be consistent with other courses.
 - Aceves: This course has some overlap with counseling courses. LOI was sent to counseling and will have a few changes on final revision.

COMPUTER SCIENCE INFORMATION SYSTEMS

 - Ayala: Track record shows demand. This will become non-credit certificate (career development/career prep certificate)
 - Kalker: These courses marked as "Library resources not adequate"
 - Ayala will follow up with instructor to see what library can use to support drone program
 - o Barrow: Forms were inconsistent with student age requirement
 - Aceves: CSIS consultant is waiting to hear back about age being lowered so high school students enrolled could register for course
 - o Barrow: Prerequisite was unclear
 - Ayala: If you have license, you can get into next course without having to take first course.
 - Barrow: Suggestion of different wording

CULINARY ARTS

ENGLISH

- Course Addition: ENGL 040
 - This class would be additional unit to a student that already took an English course.
 - Quezada: From social science aspect, if faculty can identify student within first two weeks, they can recommend course to assist with Social Science writing
 - Fulbright: What is being covered in this class that is not covered in ENG 120 or other English courses? Suggestion would be to take English course to support their writing and utilize other campus resources such as the writing center. Also have the course make the recommendation that students enroll in English writing course.
 - Kalker: Library provides research support to all courses
 - Fulbright: These are the same learning outcomes from other courses. We already
 have courses and support services available that can be utilized without adding to a
 student's load.
 - Venard: Adding on another non-degree unit would not be covered by financial aid.

Committee agreed by consensus to invite the department to a proposal review meeting to discuss their proposal.

ENGLISH AS A SECOND LANGUAGE (ESL)

- Course Addition: ESL 098C, 108
 - Fulbright: Would like to hear more about this. Wants to make sure the efforts are student centered and are pedagogically needed, rather than the students needing more units.
 - Venard: ESL students already struggle to get into these classes and the sequence will
 make things more difficult. Prerequisites need to be clear and it brings a lot of
 confusion to students.
 - Fulbright: Hope we are not utilizing curriculum for enrollment management strategies, but rather what the students need to be successful.

- Cuevas: So much similarity of what is taught in Counseling 120. Are we duplicating classes that are already helping students?
- Fulbright: We need to trust our colleagues to support our students in other areas and send them to learn these skills instead of creating courses. Creating more courses will result in multiple classes being low enrolled.
- Will bring in ESL with English and address need for course at next curriculum review meeting
- Course Modifications: ESL 098P (Number Change to ESL 093), 105
 - Venard: 105 is listed as non-degree in catalog (clerical error) and needs to be corrected
