Curriculum Proposals for November 14, 2023 Board Packet:

#### ANTHROPOLOGY

Course Modification: ANTH 215

- Aceves: Edits needed for Prerequisite, Method of Instruction, and Textbooks.
- Barrow: Asked about content review.
  - Aceves: Content review not needed.

#### BIOLOGY

Course Modifications: BIO 105, BIO 120, BIO 141,  
BIO 215, BIO 240

- Wong: For BIO 105, 120, and 141 “or” should be after “Pass” so the recommended preparation should read “A “C” grade or higher or “Pass” in English 120 or equivalent.” For BIO 141, the current catalog lists BIO 140 in the recommended preparation but the COR does not. For BIO 215, the prerequisite has different language than the other BIO courses.
- Aceves: Edits needed for requisites for BIO courses, Units and Hours for BIO 120, Instructional Facilities for BIO 120, 141, and 240, Course Content for BIO 215 and 240, Outside Class Assignments

**CARDIOVASCULAR TECHNOLOGY**

Degree Modification: Cardiovascular Technology (AS)

- Aceves: Edits needed for the GE section to include strikethroughs for MATH 103, 108, 110, and 150. The competency requirement will be updated to remove MATH 103 along with the other AHN degrees.

**CHEMISTRY**

Course Modifications: CHEM 102, CHEM 113, CHEM 115,  
CHEM 120, CHEM 141

- Aceves: Edits needed for prerequisites in CHEM 120 and 141. For CHEM 141, the prerequisite should add “or” and delete “beyond”. Edits needed for Instructional Facilities in CHEM 102, Outside Class Assignments for CHEM 120 and 141, Textbooks for CHEM 102, 113, 115, and 141.

Degree Deletion: Communication Studies (AA-T)
