#### 4. Chair Report

- District Alignment & New Programs
  - Cormier: We are looking at normalizing our system for creating new programs, and one idea is to make it district-wide and district alignment so we have a similar system and have collaboration with Cuyamaca when we are developing new programs.
  - Aceves: We want to transition into having a policy instead of unspoken rules. Both of our campuses are in agreement when it comes to program additions or things that would impact both colleges. For course alignment, we want to make sure that we both understand what alignment means to us as colleges for our courses, because we



have slightly different interpretations. The last time we visited the policy was in 2012.

- AB 927 BA/BS @ CCCs
  - Cormier: We're looking into the creation of bachelor degrees at community colleges and some have already submitted bachelor program proposals.
    - Fulbright: The State Curriculum Committee is pushing for it, but ultimately, it's not in our hands right now. There are a lot of discussions that are taking place to work things out so that community colleges have a fair chance for submitting and have a good faith discussion with our CSU colleagues. We have a group of seven or eight people going to Golden West College in a few weeks to hear presentations on this and get more information. Part of the reason why we have this new course proposal process is when it's time for us to submit, how are we going to decide what moves forward in a collaborative way for everybody to have an opportunity to put in and for the institution to make that type of decision? One round has gone through, and it's been stalled pending these discussions. There will be another round coming up, possibly in July.
    - Yang: Isn't that based on what's impacted at the State schools? Also, isn't it based upon the data or the regional needs?
      - Fulbright: It's an interpretation of the legislation. The
        interpretation was something wants to stop. The
        interpretation of "in your region" was in our meeting as
        well as the whole state which is separate from our region.
        That was not the intent of the author of the legislation.
        That's what has been adopted.
- AB 1705 CCCCO presentation on 2/7
  - Cormier: Last week, California Community College Chancellor's Office did a presentation about AB 1705, which is designed to reinforce and help implement AB 705 to get students enrolled in transfer level English and mathematics and through that more quickly. They presented evidence on the success rate of 705 so far, and they talked about the key provisions and the exceptions to the key provisions for certain students. Also, they provided resources on helping with implementation and suggestions as to how to get ready for it. A memorandum was sent out ahead of time, and there were suggestions in there.
    - Fielden: I was particularly interested in the aggregated data for students with disabilities, at least in the past. So, when they disaggregated that was very interesting to see the assumption was that students who are higher functioning with disabilities. We're sort of carrying everybody else, but it was interesting to

see how well people with various disabilities are doing.

Aceves: The State of California wants us to facilitate access to transfer level math courses immediately upon entering the community college. Students are being successful at the transfer level in larger percentage than if we were to elongate the path and add courses before. One of the big takeaways is to allow students access to the courses, but this didn't mean we had to change requisites, but it did mean that you have to provide access. So, it's relooking at how we allow students into these transfer level courses with some other criteria, so you can't have more than one requisite for a transfer level class. There's a memo about implementation that is seeking to close any loops for colleges having to add either courses before the path that a student might need a course, or before they start their degree course. The math department is working through alignment questions with Cuyamaca. I think English and ESL are in compliance right now and met 1705 requirements.

#### 5. Articulation Report

#### • P/NP

Aceves: The pass/no pass statement in the catalog is in contradiction with Title 5; so, this is a correction to our catalog in our pass/no pass, but we cleaned it up. We attempted to make it more student friendly by adding a couple of statements in here and recommendations to encourage the students to speak with a counselor, encourage the students to find out what the transfer requirements for their institution would be, and cleaning up the pass/no pass language.

#### Catalog Rights

 Aceves: We have been working on this for two semesters to update our policies to be student centered and reflect what we actually do in practice. We updated the catalog rights policy and included retroactive awards and cleaned up our continuous enrollment language, so we were able to successfully do that. Both colleges are in agreement with the language, and we would both be implementing it in the same way, and adding it exactly the same in the catalogs. The major change for the catalog rights was to include the other two public segments, so a student would be continuously enrolled as long as they maintained enrollment in a California Community College, a CSU, or a UC. Retroactive awards are something that we do in practice, but we didn't have it written in our catalog for students to know about. This clarifies that if students left our institution having all of the degrees of their catalog, they can come back and request that, and they would be granted that degree. For continuous enrollment, the major clean up and notice to students is as long as there is an official grade, and it could be

any of these that is considered your enrollment for that term. The last part was to remedy the summer sessions, but they could be used to establish catalog rights as well as maintain continuous enrollment.

#### AB 928

 Aceves: The ASCCC sent out an information item about the intersegmental of academic senate committees established what they feel will be the final lower division singular transfer G pattern. They're going to start working on the policies. We'll know definitively what that looks like in May. The plan includes six areas and the things we anticipated from the fall. There are big changes in there, and some disciplines are still trying to figure out where they can fit in terms of general education. The social sciences saw a reduction in units with the introduction of area F to Ethnic Studies and last year for CSU breadth. The Arts and Humanities section is going from nine units to six in the next year. I think we will see what the Title 5 changes will be for the associate degrees for community colleges. Once they establish the singular G pattern, the ASCCC's goal is to change Title 5 for community colleges and how we define local associate degree GE. They want to remove competencies and make the classes the way the transfer patterns are. For example, an English class would meet your writing competency and math class or anything else in that section could meet your math competency. They were holding off to make any local associate degree requirement changes for GE until after the singular G pattern, so we're anticipating very close alignment.
