A. Curriculum Proposals for May 2025 Board Packet

- 1. Business Office Technology (BOT)

B. AP 4025: Philosophy & Criteria for Associate Degree and General Education

• Reviewed to ensure Title 5 alignment and consistency across the district.

C. AP 4235: Credit for Prior Learning (CPL)

- Updates discussed regarding equity and access.
- New requirement: Students must have a comprehensive ed plan.
- Statement added to ensure aligned courses earn equal CPL credit at both colleges.

D. Accreditation: Standard II - Draft

- Overview provided by Denise and Joan from the Accreditation Steering Committee.
- Committee asked to review the 21-page document via OneDrive and provide feedback.
- Emphasis on:
 - Responsive curriculum (e.g., LVN-to-RN Bridge, trauma-informed CD certificate, Al programs).
 - Outcome assessment follow-through.
 - SLO accuracy and updating CORs.
 - Access to and visibility of current curriculum materials.

E. Curriculum Institute (July 9–12, 2025)

- Open for in-person or virtual attendance.
- Funded by AB 1111 and AB 928.
- Survey sent out for interested attendees.

F. Assigning Courses to Disciplines

- Approximately 1300 courses need to be assigned to disciplines per Minimum Qualifications (MQs).
- Discussion included:
 - o Faculty involvement through department-level review.
 - Use of spreadsheets and guidance materials from ASCCC and other districts.
 - Reaffirmed that this process is required for accreditation and will be integrated with the new CIM system.

- Approved changes:
 - Replace Instructional Operations Supervisor with Curriculum Specialist as a voting member.
 - Remove **Distance Education Coordinator** from Advisory Member list (confirmed by DE Coordinator via email).
- Updates sent to Academic Senate for formal approval.

 - Curriculum Management System (CIM) rollout.
 - IDEAA: Inclusion, Diversity, Equity, Anti-Racism, and Accessibility in curriculum forms and processes.
