


the meeting agendas and minutes should be posted to the website. Nothing has been posted since May. This lacks transparency and violates the spirit of participatory governance. The council has not made any substantive decisions/recommendations since its inception and largely serves as a rubber stamp for recommendations made by other committees.

College Council has shown improvement in many areas since Bill McGreevy became the Convenor. I also believe that the governance structure as a whole needs some fine-tuning as many participants do not understand how information flows within and between the committees. We could all use some additional training in this area. For example, when a body such as the Technology Committee recommends the purchase and implementation a new program or piece of hardware, is the Budget Committee tasked with finding the funding to support such a purchase? If not, which body does? And, how do the various constituency groups receive information and updates from their members? Recently the faculty declined to address a motion brought to College Council from the Technology Committee because this was the first time they were made aware of this request. However, the Classified members had communicated the proposed motion to their constituents and the motion was agreed upon by Classified. This is definitely an area that needs improvement.

Students leaders, especially now are spread thin. Making it difficult to attend all the committees.


