The Chancellor's Office has developed a process for reviewing baccalaureate degree programs across nine required components:

- Policy Compliance: proposed BDP conforms to what is legally required
- Institutional Financial Stability
- Equitable Student Outcomes
- Program Quality: approval criteria and scoring rubric
- Non duplication and Intersegmental Agreement: negotiations with CSU and UC; written agreement required
- Institutional Capacity
- Curriculum and Program Design
- ACCJC Approval: required for programs to be established; colleges submit proof of approval
- BOG President Approval (informational item to the full board)

Upon completion of the application review process, applications that are policy compliant, earn a passing program quality review score, and have intersegmental agreement will be provided to the Board of Governors' President for review and approval.



Feasibility Policy

Program Feasibility Review is a process meant to assure that the College's instructional resources are used in response to the College's Mission, Strategic Plan and Educational Master Plan; the needs of its students ; and the requirements of the community it serves.
