H. Reinstating Parking Fees

Cesar Nunez | 20 minutes (info/discussion/action)

The board will discuss the reinstating of the parking fees and give our opinion to the chancellor.

Background:

- The fees were waived due to COVID financial restraints in an effort to help students during this time.
- We are the only district locally that continued to waive them in an attempt to help students where we could.
- In addition to parking, the fees provide:
 - o free escort services
 - o free vehicle unlocks when students lock their keys in their car or lose their keys
 - o free battery jumps when students leave lights on or has other related issues
 - o and more...
- Parking fees are necessary to build, operate, and maintain parking lots (repaving, lights, repainting, etc.) and provide adequate parking and safe movement of pedestrians and vehicles.
- GCCCD permit rates and parking fines are generally amongst the lowest in the state \$40/Semester; \$18 summer.
- The revenue generated by parking fees can ONLY be used for building, operating, maintaining, and providing security for parking facilities on campus.

ASGC recommendations:

- Lowering the permit fee to \$35.
- When parking fees are enacted, it should be well publicized. Students stated there are signs on campus now that state you must pay for parking. People have become immune to the signage and likely wouldn't know they need to pay.
 - There is usually a 2 week grace period at the start of the semester where CAPS does not ticket for non-permit violations.
- When the fees are enacted, there should be an educational campaign so students know the fees and understand how they are used.
 - o CAPS services discussed above, etc.
- Purchasing the pass should be a part of online registration/payment of fees so students are not surprised with a new fee they had not planned on.
- Can Basic Needs and other programs can pay for a student's parking if it is a financial barrier.
 - o Sara will do some research and follow-up.

• To ease the shock for students, ASGC discussed the possibility of subsidizing a small portion of the parking pass for the Fall 2024 semester by offering a discount/reimbursement to students who purchase the ASGC Benefit Sticker. As an example, if a student purchases the benefit sticker, they could come to the Activities Window for a \$5 reimbursement for parking (amongst the other sticker benefits). They will explore.
