The board will receive information regarding the Spring 2025 Scholarship.

- The foundation works with community donors to provide scholarships each semester
- We distribute over 350 scholarships and nearly \$300,000 every semester
- Scholarship amounts can range from \$100-\$2,500 (most scholarships at \$500)
- Students apply through one simple online application that matches them with scholarships they qualify for automatically
- Scholarships are funded through your preferred payment method in Bank Mobile
